

OFFICIAL RULES: "BARTABLE HASHTAG CONTEST" SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. VALID ONLY IN CALIFORNIA. VOID WHERE PROHIBITED. NEED NOT BE PRESENT TO WIN.

1. Sponsor is San Francisco Bay Area Rapid Transit District (BART), P.O. Box 12688 (LKS-18) Oakland, CA 94604-2688.

2. Entry Period: The BARTable Hashtag Sweepstakes (this "Sweepstakes") begins on June 13, 2018, at 12:01 AM Pacific Daylight Time ("PDT"), and ends on June 25, 2018, at 11:59 PM PDT (the "Entry Period"). Sponsor's computer is the official time-keeping device for this Sweepstakes.

3. Eligibility: This Sweepstakes is open only to U.S. legal residents of California who are 18 years of age or older at the time of entry. Employees and agents of Sponsor, and their immediate family members and persons residing in the same household of such employees are not eligible to enter or win. "Immediate family members" shall mean parents, spouses, children, siblings or grandparents and each of their respective spouses, regardless of where they reside. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law. The Alameda County Fair ticket is valid for one fairgrounds admission June 15 to July 8. The weekend promotional BART ticket is valid for one round-trip ride on BART on Saturdays or Sundays through July 8, 2018. All government taxes and surcharges will be the responsibility of the winner.

Potential winner will be notified by Instagram direct message. If potential winner does not respond within 72 hours, or if prize notification is returned as undeliverable, prize will be forfeited, and an alternate winner will be selected via random drawing. Providing all eligibility requirements are met, potential winner must claim prize at Sponsor's headquarters in Oakland, CA, or another location specified by Sponsor.

5. How to enter: The Sweepstakes must be entered by submitting an entry using Instagram. To enter, follow @SFBARTable on Instagram. Post a new photo showing your favorite things places to visit or things to do on the weekend by using BART. Use the hashtag #sfbartable. Tag @SFBARTable in the post. The post must be public to have the entry be eligible.

6. Except where prohibited by law, potential winner may be required to complete, sign and return an Affidavit of Eligibility/Ownership/Liability Release and Publicity Release (the "Affidavit") prior to claiming prize. Affidavit must be returned within fourteen (14) calendar days or prize may be forfeited and an alternate winner will be selected. In the event of noncompliance with these requirements, the prize will be forfeited and an alternate winner will be selected.
