

OFFICIAL RULES: BARTABLE "2018 BARTABLE BACK TO SCHOOL SWEEPSTAKES"

NO PURCHASE NECESSARY TO ENTER OR WIN. VALID ONLY IN CALIFORNIA. VOID WHERE PROHIBITED. NEED NOT BE PRESENT TO WIN.

Entry: To enter, follow the sweepstakes prompt to complete the registration process. Public libraries have free internet access. Each participant will need to provide the following information to be entered into the Promotion: first and last name and email address. By completing and submitting the sweepstakes registration during the promotion period, each participant will earn one (1) sweepstakes entry. Participant can complete a bonus action by following the BARTable Twitter account, tweeting about the contest on Twitter, following the BARTable Instagram account or referring a friend to the contest. Each bonus action will earn an additional entry to the sweepstakes. A maximum of four bonus entries will be awarded. Limit of (5) entries per participant during the promotion period.

1. Sponsor is San Francisco Bay Area Rapid Transit District (BART), P.O. Box 12688 (LKS-18) Oakland Ca 94604-2688.

2. Entry Period: The BARTable Back to School Sweepstakes (this "Sweepstakes") begins on July 26, 2018, at 12:01 AM Pacific Daylight Time ("PDT"), and ends on August 5, 2018, at 11:59 PM PDT (the "Entry Period"). Sponsor's computer is the official time-keeping device for this Sweepstakes.

3. Eligibility: This Sweepstakes is open only to U.S. legal residents of California who are 18 years of age or older at the time of entry. Employees and agents of Sponsor and their immediate family members and persons residing in the same household of such employees are not eligible to enter or win. "Immediate family members" shall mean parents, spouses, children, siblings or grandparents and each of their respective spouses, regardless of where they reside. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law.
