

OFFICIAL RULES: CHECK IN TO WIN EAT REAL SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. VALID ONLY IN CALIFORNIA. VOID WHERE PROHIBITED. NEED NOT BE PRESENT TO WIN.

Entry: To enter, follow the sweepstakes prompt at bartable.bart.gov/contests/check-win-eat-real-vip-prize-package. Public libraries have free internet access. Each participant will need to do the following to be entered into the Promotion: Use Facebook's "check-in" feature to check in to a restaurant within half-mile or 6 blocks of a BART station; upload a photo and tag @BARTable and use the hashtag #BARTable in the post description; have the post be public so BARTable can see the entry. By completing and submitting the sweepstakes registration during the promotion period, each participant will earn one (1) sweepstakes entry. Limit of one (1) entry per participant during the promotion period.

1. Sponsor is San Francisco Bay Area Rapid Transit District (BART), P.O. Box 12688 (LKS-18) Oakland Ca 94604-2688.

2. Eligibility: This Sweepstakes is open only to U.S. legal residents of California who are 18 years of age or older at the time of entry. Employees and agents of Sponsor, or any Eat Real Festival employees, and their immediate family members and persons residing in the same household of such employees are not eligible to enter or win. "Immediate family members" shall mean parents, spouses, children, siblings or grandparents and each of their respective spouses, regardless of where they reside. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to this Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

3. Drawing: Around Sept. 19, 2016, sponsor will conduct a random drawing for an Eat Real Festival VIP prize package. Potential winner will be notified by email by Sept. 19. If potential winner does not respond within 24 hours, or if prize notification is returned as undeliverable, prize will be forfeited, and an alternate winner will be selected via random drawing. Providing all eligibility requirements are met, potential winner must claim prize at Sponsor's headquarters in Oakland, CA, or another location specified by Sponsor.
