

OFFICIAL RULES: OAKLAND ART MURMUR SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. VALID ONLY IN CALIFORNIA. VOID WHERE PROHIBITED. NEED NOT BE PRESENT TO WIN.

Entry: To enter, follow the sweepstakes prompt at bartable.bart.gov. Public libraries have free internet access. Each participant will need to do the following to be entered into the Promotion:

Use Facebook's "check-in" feature to check in to a gallery or the official Oakland Art MurmurSM visual arts venue on the official Oakland Art Murmur Facebook page. Venue must be within half-mile or 6 blocks of a BART station. Entrant can also enter sweepstakes by uploading a selfie and posting it on Facebook, Twitter and Instagram with the #BARTable and #SaturdayStroll in the post description. Make sure the post is public so it is visible. By completing and submitting the sweepstakes registration during the promotion period, each participant will earn one (1) sweepstakes entry. Limit of one (1) entry per participant during the promotion period.

1. Sponsors are San Francisco Bay Area Rapid Transit District (BART), P.O. Box 12688 (LKS-18) Oakland Ca 94604-2688 and Oakland Art MurmurSM, 416 26th Street, Oakland, CA 94612.

2. Eligibility: This Sweepstakes is open only to U.S. legal residents of California who are 18 years of age or older at the time of entry. Employees and agents of Sponsor, or any Eat Real Festival employees, and their immediate family members and persons residing in the same household of such employees are not eligible to enter or win. "Immediate family members" shall mean parents, spouses, children, siblings or grandparents and each of their respective spouses, regardless of where they reside. If potential winner does not respond within 24 hours, or if prize notification is returned as undeliverable, prize will be forfeited, and an alternate winner will be selected via random drawing. Providing all eligibility requirements are met, sponsor will send prizes to each qualified winner by US mail; please allow 2 to 4 weeks for delivery.
