

OFFICIAL RULES: WIN TICKETS TO SEE CAL SHAKES' "ROMEO Y JULIET" (the "Sweepstakes")

NO PURCHASE NECESSARY TO ENTER OR WIN. VALID ONLY IN CALIFORNIA. VOID WHERE PROHIBITED. NEED NOT BE PRESENT TO WIN.

1. Entry: To enter, follow the sweepstakes prompt to complete the registration process. Each entrant will need to provide the following information to be entered into the Sweepstakes: email address. Upon sweepstakes entry, entrants will be given the option to subscribe to the *BARTable This Week* email newsletter. By completing and submitting the Sweepstakes registration during the Entry Period, each such entrant will earn one (1) Sweepstakes entry. Limit of one (1) entry per entrant during the Entry Period. Additional entries beyond the specified limit will be void. All information submitted online via the form will be subject to, and treated in a manner consistent with, Sponsor's privacy policy accessible at bart.gov/siteinfo/privacy.aspx.

2. Sponsor of the Sweepstakes is San Francisco Bay Area Rapid Transit District (BART), 2150 Webster St., 10th Floor, Oakland, CA 94612 ("Sponsor").

3. Entry Period: The Sweepstakes begins on Monday, May 30, 2022 at 08:00 AM Pacific Daylight Time ("PDT") and ends on Sunday, June 5, 2022 at 11:59 PM PDT (the "Entry Period"). Sponsor's computer is the official time-keeping device for this Sweepstakes.

4. Eligibility: This Sweepstakes is open only to U.S. legal residents of California who are eighteen (18) years of age or older at the time of entry and have not won a BARTable Sweepstakes in the last ninety (90) days. Employees and agents of Sponsor, their immediate family members and persons residing in the same household of such employees are not eligible to enter or win. "Immediate family members" shall mean parents, spouses, children, siblings or grandparents and each of their respective spouses, regardless of where they reside. This Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void outside California and where prohibited or restricted by law, rule or regulation. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to this Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

5. Drawing: On or about Monday, June 6, 2022 ("Drawing Date"), five (5) potential winners will be selected in a random drawing that will be conducted by Sponsor from among all eligible entries received. Entrant need not be present to win.

6. Notification: Potential winner will be notified by email. If potential winner does not respond within twenty-four (24) hours, or if prize notification is returned as undeliverable, prize will be forfeited, and an alternate potential winner will, time permitting, be selected via random drawing from among all remaining eligible entries received. Providing all eligibility requirements are met and potential winner is otherwise in compliance with these Official Rules, potential winner will be declared the official winner of the Sweepstakes. Winner will claim prize on date and location designated in confirmation email from Sponsor. Except where prohibited by law, potential winner may be required to complete, sign and return an Affidavit of Eligibility/Ownership/Liability Release and Publicity Release (the "Affidavit") prior to claiming prize. Affidavit must be returned within twenty-four (24) hours, or prize may be forfeited, and an alternate winner will, time permitting, be selected by random drawing from among all remaining eligible entries. In the event of noncompliance with these requirements, the prize will be forfeited, and an alternate potential winner will, time permitting, be selected as set forth herein.

7. Prize/Odds: Five (5) prizes will be awarded. Odds of winning depend on the number of eligible entries received. DESCRIPTION OF PRIZE: Two (2) tickets to Cal Shakes' "Romeo y Juliet" at Bruns Amphitheatre in Orinda on Saturday, June 18, 2022 at 2pm.

8. Prize Conditions: Winner's guests must be of legal age of majority in their jurisdictions of residence (and at least eighteen (18) years of age), unless accompanied by a parent or legal guardian. Released Parties (defined below) will not be responsible for weather conditions, Acts of God, acts of terrorism, civil disturbances, work stoppage or any other natural disaster outside their control that may cause the cancellation or postponement of any event or exhibition. Event and exhibition tickets awarded as prizes may not be resold or offered for resale or used for any commercial or promotional purpose whatsoever. Any such resale or commercial or promotional use may result in disqualification and prize forfeiture and may invalidate the event or exhibition tickets. Winner is fully responsible for any and all applicable federal, state and local taxes (including income and withholding taxes) on the prize and any other costs incurred in claiming or using the prize, including any transportation costs beyond that awarded.
