

OFFICIAL RULES: WIN A ROCKRIDGE SHOP SMALL PRIZE PACKAGE WORTH \$1,400 (the "Sweepstakes")

1. Entry: To enter, follow the sweepstakes prompt to complete the registration process. Each entrant will need to provide the following information to be entered into the Sweepstakes: email address. Upon sweepstakes entry, entrants will be given the option to subscribe to the *BARTable This Week* email newsletter. By completing and submitting the Sweepstakes registration during the Entry Period, each such entrant will earn one (1) Sweepstakes entry. Limit of one (1) entry per entrant during the Entry Period. Additional entries beyond the specified limit will be void.
